

## --- Application and limitations of use:

This chemical apron is to be used in certain chemical environments only and at room temperature. Product is designed for acids, alkalis, alcohols and chlorinated hydrocarbons. The users wear the chemical apron under strict time frames.

It is advised to not use this product in temperatures below 40 degrees Fahrenheit or above 85 degrees Fahrenheit.

#### -- Fitting and use:

Upon removing garment from the package, use a "buddy system" to ensure the garment is properly fit, in proper position and tied in the back to ensure maximum coverage and a secure fit. Before use ensure the garment is free from tears and any other cosmetic defects. Ensure all snaps and /or ties are present.

-- Removal: Unfasten the ties on the back, then take off sleeves.

## -- Maintenance and cleaning:

When the aprons are contaminated, use a wet soft cloth to clean. It is not necessary to disinfect the aprons.

- --Special attention to potential problems which may be caused by deterioration of special repellency treatments and the correct method of reapplying and/or regenerating this treatment;
- -- Storage: This product shall be stored in non-humid environment.
- --Warnings: Prolonged wearing of the chemical apron may cause heat stress. If this happens, immediately remove the gown and seek a cooler area. Comfort related parameters are not applicable.
